Veterans For Child Rescue was founded specifically to help bring an end to child trafficking. Our primary methods are to widely expose the threat through multiple mass media platforms and to directly combat the problem by running joint sting operations against traffickers with law enforcement and allied NGOs.

Protect our children: The V4CR Nationwide Volunteer team provides free educational outreach programs to arm citizens with the necessary tools to protect their children and maintain safe communities. In 2018, the V4CR staff and volunteers carried on 35 public outreach events.
